Nzoia Water Services Company (NZOWASCO) Ltd is a limited liability Company established in 2004 under the Companies Act, Cap 486 of laws of Kenya (now repealed). The Company is jointly owned by Bungoma and Trans-Nzoia County Governments in accordance with relevant provisions of the Constitution of Kenya, 2010, Water Act, 2016, County Governments Act, 2012 and the Companies Act, 2015.

The Board of Directors (the Board) comprise of representatives of stakeholders identified in accordance with Corporate Governance Guidelines issued by Water Services Regulatory Board (WASREB)

The Company has two (2) vacant positions in the Board and invite applications from representatives of the following stakeholder groups;

- (i) One (1) Director from Bungoma County nominated by a body of professionals representing accountants, Auditors, supply chain, public secretaries, engineers, lawyers, doctors, human resource, surveyors, training institutes, arbitrators, among others.
- (ii) One (1) Director from Trans- Nzoia County nominated by a duly registered organization representing resident organization(s).

The applicants should meet the following criteria:

- (i) Minimum holder of a Bachelor's Degree from a recognized university in Kenya or equivalent professional qualification

- (ii) Demonstrated experience and acumen in business or any profession for at least Seven (7) years.
- (iii) **MUST** be from a stakeholder group recognized by the Company.
- (iv) Be a resident of the area served by the Company
- (v) **MUST** meet the Fit and Proper Test criteria set by **WASREB** available on **WASREB's** website - www.wasreb.go.ke. The submitted copy **MUST** be duly filled, signed by the applicant and stamped by a commissioner of oaths or magistrate
- (vi) Successive candidates will be required to meet leadership and integrity criteria set out under Chapter Six of the Constitution of Kenya, 2010 by submitting the following clearance certificates issued within the last 12 months: **KRA, CRB, HELB, GOOD CONDUCT & EACC**

NOTE:

- (i) Suppliers and other trading associates of the Company are not eligible for directorship positions of the Company
- (ii) Representation by stakeholder groups in the Board of the Company is on rotational basis hence professional bodies and resident organizations not represented in the just ended or expired Board are encouraged to apply.
- (iii) Nominating organizations are encouraged to nominate women for consideration to ensure one-third gender rule as required under the constitution
